CHAPTER 8 Traffic Code

8.01.000 PROVISIONS OF STATE LAW ADOPTED BY REFERENCE.

8.01.010 State Traffic Forfeiture Laws and Rules Adopted. Except as otherwise specifically provided in this ordinance, all provisions of the general body of law in Chapters 340 to 348 of Wisconsin Statutes and Rules of the Department of Transportation in TRANS 305, describing and defining regulations with respect to vehicle and traffic and equipment for which the penalty is a forfeiture only, including penalties to be imposed and procedures for prosecution, are hereby adopted and by reference made a part of this ordinance as if fully set forth herein. Any act required to be performed or prohibited by any statute or rule incorporated herein by reference is required or prohibited by this ordinance. 8.01.020 Other Laws Adopted. 8.02.000 SPEED LIMITS. The Common Council of the City of Port Washington hereby determines that the statutory speed limits on the following street or portions thereof are unreasonable, unsafe or imprudent and modifies such speed limits under authority granted by S.349.11 of the statutes as follows:

8.05.020 <u>Parking Meters</u>. Parking meters shall be installed by the Board of Public Works in compliance with the provisions of 8.05.010.

- A. Parking Meter Zones and Time Limits. No person shall, without depositing the parking meter fees hereinafter required, park a vehicle in any parking meter zone, including public parking lots, for longer than the period specified on the parking meter, at any time between the hours of 8:00 a.m. and 6:00 p.m., and between the hours of 8:00 a.m. and 9:00 p.m. on Fridays, except Sundays and the following legal holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day. Notwithstanding the time and date limitations set forth herein, no vehicle shall be parked upon any public parking lot for more than 24 consecutive hours, and no vehicle shall be parked in a public parking lot except in areas where permitted.
- B. Parking Meter Fees. Upon parking any vehicle in a parking meter zone, including public parking lots, at any time during which the provisions of this ordinance are in effect, the operator of a vehicle shall deposit or cause to be deposited in the parking meter or meters controlling the parking spaces utilized, immediately after parking, such coin or coins of the legal tender of the United States of America and in such amounts as specified on the parking meter, and failure to do so shall constitute a violation of this section. The operator or citizen must turn the handle of the parking meter after depositing the coin or coins to put the meter in operating condition.

C. Miscellaneous Provisions.

- **C-1** In all parking meter zones, a parking meter shall be installed for each parking space. All parking spaces shall be plainly marked by lines on the street surface.
- C-2 Parking meters shall be installed upon the sidewalk or curb immediately adjacent to each designated parking space. Each parking meter shall indicate by a proper legend the established rate and legal parking time, and when in operation, shall also indicate by a dial or pointer the duration of the legal parking and any over parking.
- **C-3** Any vehicle parking in any parking meter zone any time during which the provisions of this section are in effect shall be legally parked within the marked lines of the designated parking space. The parking of any vehicle, which because of its size requires more than one parking space for legal parking, shall be controlled by the several individual parking meters adjacent to all parking spaces utilized.
- **C-4** The coins hereby required to be deposited are levied and assessed as fees to provide revenue to meet the cost of regulation of parking, to make provisions for additional parking places off the street, and such other expenses and purposes deemed reasonably necessary to provide for the convenience, safety and welfare of persons using the street and highways of this city for vehicular traffic, including general street and highway maintenance, repair and construction.
- **C-5** No persons shall deposit, or cause to be deposited in any parking meter, any slug device, foreign substance or substitute a coin of the United States.
- C-6 No person shall deface, injure, tamper, or willfully break, destroy or impair the usefulness of any parking meters.
- C-7 Notwithstanding the time and date limitations as set forth in Section 8.05.020 A., no person shall park a vehicle in any of the following parking meter zones, known as the Marina parking meter zones, for a longer period than twenty consecutive hours upon deposit of ten cents per hour:
- 1. The westerly tier of parking spaces in the parking lot bounded by East Washington Street, City Street, East Pier Street, and Lake Street.
- 2. The parking lot bounded by Lake Street, East Pier Street, East Jackson Street and the private property to the west.
- 3. (Repealed) 8/17/2010
- 4. The parking lot extending from the centerline of Pier 2 of the Marina extended westerly and bounded by Lake Street, Lake Michigan and the north line of the City Park.
- 5. East Jackson Street from its intersection with Lake Street east to the end of East Jackson Street.
- D. Permit Parking. Monthly parking permits shall be available which shall entitle the holder to occupy a parking space in the following public parking lots, as identified by signs, during the periods specified herein, without the requirement that any coins be deposited into the parking meter of such parking space:

- 1. The public parking lot bounded by East Grand Avenue on the south, an alley running from North Franklin Street west to North Wisconsin Street on the north, the east boundary line of the property at 126 East Grand Avenue on the east, and the east boundary line of the property at 118 East Grand Avenue on the west, all year, except those portions of said public parking lot identified by signs as 15-minute parking spaces.
- 2. The public parking lot bounded by East Grand Avenue on the south, East Main Street on the north, the west boundary of the North Slip on the east, and the east boundary lines of the properties at 100, 114, 122 and 128 North Franklin Street on the west (said lot also identified as Municipal Lot C-4 in Figure 1 of Section 8.05.030), but excluding the five (5) northernmost parking spaces in the easternmost row of parking spaces in said lot between the period from April 1 to October 31, inclusive, during which times parking in said parking spaces is limited to 30 minutes.
- 3. The south row of parking spaces in the public parking lot bounded by the north boundary of the North Slip on the south, East Washington Street on the north, Lake Street on the east, and Harborview Lane on the west (said lot also identified as Municipal Lot M-1 in Figure 1 of Section 8.05.030), Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m. only.

A monthly parking permit shall be available for such fee as determined from time to time by resolution of the Common Council. Except as provided in Section 8.05.020 D. 3., above, the parking permit shall be valid for up to ten consecutive hours on any weekday between the hours of 7:00 a.m. and 7:00 p.m. A permit issued under this section shall be valid for an entire calendar month and the cost shall not be prorated. The permit shall be issued to an individual and shall not be transferable to another person. Not more than one permit shall be issued to any applicant, individually or through any agent, representative or employee, during any calendar month. The permit shall be in such form as determined by the City Administrator, and may be obtained from the Police Department upon payment of the prescribed fee and completion of an application in such form as determined by the City Administrator. No person shall duplicate a parking permit issued under this section.

- **C-8** The five (5) northernmost parking spaces in the easternmost row of parking spaces in the public parking lot bounded by East Grand Avenue on the south, East Main Street on the north, the west boundary of the North Slip on the east, and the east boundary lines of the properties at 100, 114, 122 and 128 North Franklin Street on the west (said lot also identified as Municipal Lot C-4 in Figure 1 of Section 8.05.030), between the period from April 1 to October 31, inclusive.
 - **8.05.030** All-Night Parking Regulated. A. When signs have been erected at or reasonably near the corporate limits of the city as provided in S.349.13, Wis. Stats., no person shall park any vehicle for a period between 2:00 a.m. and 6:00 a.m. on any of the following streets, except physicians on emergency calls:
 - 1. On any street within the city, between the period from 2:00 a.m. December 1, to 6:00 a.m. April 1, inclusive.
 - 2. On State Trunk Highway 32 and 33 within the city, on all days.
 - B. The Police Department may, at the discretion of the commanding officer of the shift during which a request is made, permit one or more vehicles per residential unit to park

on a city street otherwise prohibited under A.1. above, upon making a determination that said parking prohibition is unreasonably burdensome to the occupants of said residential unit. Said permission shall be granted for a single day at a time, on an occasional basis only, pursuant to general policy guidelines determined by the Chief of Police.

- C. 1. Notwithstanding the provisions of Section 8.05.020 A., no vehicle shall be parked overnight in the following parking lots, as identified in Figure 1 hereinbelow, from October 1st to April 30th, inclusive, without a permit:
 - (a) Municipal Lot C-1
 - (b) Municipal Lot C-2
 - (c) Municipal Lot C-3
 - (d) Marina Lot M-1
 - (e) Marina Lot M-2
 - (f) Marina Lot M-3
- 2. Notwithstanding the provisions of Section 8.05.020 A., no vehicle shall be parked overnight in the following parking lots, as identified in Figure 1 hereinbelow, from May 1st to September 30th, inclusive, without a permit:
 - (a) Municipal Lot C-1
 - (b) Municipal Lot C-2
 - (c) Municipal Lot C-3
- 3. As used in Sections 8.05.030 C.1. and 2., "overnight" shall mean continuously from 7:00 p.m. one day to 7:00 a.m. the following day. Permits shall be valid for a calendar month at a fee to be determined from time to time by resolution of the Common Council. The permit fee shall not be prorated. The application and permit forms shall be as determined by the Police Department. A permit may be obtained from the Police Department upon completion and approval of an application and payment of the prescribed fee. A permit shall be issued to a specific vehicle and shall not be transferable. When issued a permit shall allow overnight parking only in the parking lot designated in the permit.
- **8.05.040** Angle Parking Permitted. Angle parking within defined areas shall be permitted and where clearly designated by official traffic signs on the following streets:
- 1. On the west side of South Milwaukee Street and south of Grand Avenue.
- 2. On the south side of East Main Street from North Wisconsin Street to North Franklin Street, except for that space or portion of said street reserved for the parking of vehicles used by physically disabled persons, as provided in Section 8.05.050 N.
- 3. On the east side of Lake Street from a point 440 north of the north curbline of E. Jackson Street to a point 370 feet northerly thereof;
- 4. On South Franklin Street and south of East Grand Avenue.
- 5. On the north side of East Grand Avenue from a point 22 feet east of the east curb line of Franklin Street extended, to a point 92 feet easterly thereof.

- 6. On the north and south sides of W. Main Street, between N. Milwaukee Street and N. Wisconsin Street.
- 7. On the west side of Lake Street from a point 410 feet north of the north curbline of E. Jackson Street to a point 125 feet north thereof;
- 8. On the north side of E. Main Street from Franklin Street east to the first driveway.

8.05.050 Miscellaneous Parking Provisions.

- A. **1. <u>Definitions.</u>** As used in this subsection, the following words or phrases have the designated meanings:
 - (a) "Authorized emergency vehicle," "camping trailer," "mobile Home," "motor bus," "motor home," "recreational vehicle," "school bus," "trailer" and "vehicle" shall have the meaning assigned to such terms under sec. 340.01 of the Wisconsin Statutes, as amended.
 - (b) "Park" or "parking" means the halting of a vehicle, whether occupied or not, whether carrying property or passengers or not, and whether drawn by a motor vehicle or not, except temporarily for the purpose of and while actually engaged in loading or unloading property or passengers.
 - (c) "Street" and "highway" shall have the meaning assigned to such terms under sec. 340.01 of the Wisconsin Statutes, as amended. "Public right-of-way" means any way or area which the public has a right to travel or use.
 - **2.** <u>Street, highway and public right-of-way parking restricted.</u> Except as otherwise provided in this Chapter, no person shall park any vehicle on any street, highway or public right-of-way of the City for more than twenty-four (24 consecutive hours.
 - 3. Parking restrictions for camping trailers, recreational vehicles, trailers and certain other vehicles; enforcement. No person owning or having control of any camping trailer, mobile home, motor bus, motor home, recreational vehicle, school bus or trailer shall park the same upon any street, highway or public right-of-way of the City for a period exceeding four (4) days, whether consecutive or in the aggregate, per month.
 - **4.** Exceptions. The provisions of subsection A.3 hereof shall not apply to authorized emergency vehicles, and shall not prohibit, nor be deemed to prohibit, the lawful parking of any vehicle described in subsection A.3. upon any street, highway or public right-of-way of the City specifically designated for such purpose, or as authorized by a valid parking permit.
- B. No person other than regular employees and elected officials of the city shall park a motor vehicle in the parking lot north and adjacent to the municipal building between 6:00 a.m. to 6:00 p.m.
- C. No person shall leave a motor vehicle parked or standing unattended with its motor running.
- D. No person shall park any commercial vehicle in a district zoned for residence purposes under the city zoning code.
- E. No person shall stop or leave any vehicle standing in the following designated loading zones, except temporarily for the purpose of and while actually engaged in loading or unloading or in receiving or discharging passengers and while the vehicle is attended by a licensed operator so that it may be promptly moved in case of an emergency.

- 1. The North side of Oakland Avenue from a point 364 feet west of the west curb extended of S. Park Street, to a point 708 feet westerly thereof.
- 2. The south side of East Main Street from a point 180 feet east of the east curb line on North Wisconsin Street to a point 198 feet easterly thereof.
- 3. The north side of East Main Street from a point 28 feet west of the west curb line on North Franklin Street to a point 56 feet westerly thereof.
- 4. The north side of East Washington Street from a point 141 feet east, of the east curb line of North Franklin Street to a point 229 feet easterly thereof.
- 5. The north side of East Pier Street to a point 32 feet east of the east curb line of North Wisconsin Street to a point 85 feet easterly thereof.
- 6. (Repealed 8/06)
- 7. On the south side of West Main Street from a point 137 feet west of the west curb of North Wisconsin Street to a point 49 feet westerly thereof from 8:00 a.m. to 5:00 p.m.
- 8. (Repealed) 11/16/2010
- 9. On the south side of West Foster Street, for a distance of 39 feet west of the west curb line of South Webster Street.
- F. Miscellaneous Parking Provisions. No person shall park any vehicle in any alley at any time.
- G. From May 1, through September 30, self-contained recreational vehicles, defined as a vehicle which contains electric power and lights, water system, toilet and sewage holding tank, shall not be parked on any city street, alley or parking lot in an area bounded by the east curb line on North Franklin Street, the north curb line of East Jackson Street until it intersects with the west curb line of Lake Street, northerly and including all streets and alleys and parking areas or parks to the north limits of the Upper Lake Park, easterly to the shore of Lake Michigan southerly along the shore of Lake Michigan to the south line of the Marina Peninsula Park, northerly and westerly along the north slip of the harbor and the south line of Washington Street to the east curb line of North Franklin Street, EXCEPT where specifically and exclusively provided for and then only upon payment of a permit fee of ten (\$10.00) dollars for each twenty-four hours or portion thereof, obtainable from the authorized representative of the City of Port Washington. In addition, those persons granted a Marina Parking Permit who are actively using Marina facilities may be allowed to sleep overnight in the above designated areas for no more than 4 overnights in a 7-day period. The type of vehicles in which temporary overnight parking and sleeping is permitted are: recreational vehicles, camping trailers, motor homes, buses, conversion vans and truck campers. There shall be no more than 3 vehicles parked overnight in the above-designated areas. Any temporary overnight parking permit granted under this section is subject to revocation or suspension for cause by the City upon a citation or complaint being issued to a permittee and signed by a law enforcement officer, building inspector, local health officer or Harbormaster.
- H. <u>Parking for Police and Fire Department Personnel Only</u>. No person other than Police and Fire Department Personnel shall park a motor vehicle on the south side of West Washington Street from a point 150 feet west from the west curb line of North Wisconsin Street to the first curb line of North Milwaukee Street.
- I. <u>Parking for Fire Department Personnel Only</u>. No person other than Fire Department Personnel shall park a motor vehicle on the east side of North Wisconsin Street between Pier Street and Washington Street.

- J. No person shall move any vehicle for purposes of evading limitations set forth in these ordinances or otherwise interfere with any marks or activities or any city official with the intention of evading or preventing the enforcement of parking provisions herein.
- K. No person shall park a vehicle for longer than fifteen (15) minutes in the two (2) parking spaces, as identified by signs, located in the public parking lot bounded by East Grand Avenue on the south, an alley running from North Franklin Street west to North Wisconsin Street on the north, the east boundary line of the property at 126 East Grand Avenue on the east, and the east boundary line of the property at 118 East Grand Avenue on the west.

The penalty for violation of this ordinance shall be twenty-five (\$25.00) dollars for each twenty-four hour period, or portion thereof.

- L. No person shall stop, park or leave standing any vehicle except a school bus in the following designated passenger loading/unloading zones, which shall be reserved for the temporary loading or unloading of passengers by school buses while such buses are actually engaged in receiving or discharging passengers and while such buses are attended by a licensed operator so that such buses may be promptly moved in case of an emergency:
 - 1. The west side of North Holden Street from its intersection with the north curb line of West Jackson Street, extended, to a point 256 feet northerly thereof from 7:00 a.m. to 4:00 p.m. on days when school is in session.
 - 2. The south side of West Jackson Street from the west curb line of North Webster Street to the east curb line of North Holden Street, extended, from 7:00 a.m. to 4:00 p.m. on days when school is in session.
- M. No person shall stop, park or leave standing any school bus in the following designated passenger loading/unloading zones, which shall be reserved for the temporary loading or unloading of passengers by vehicles other than school buses while such vehicles are actually engaged in receiving or discharging passengers and while such vehicles are attended by a licensed operator so that such vehicles may be promptly moved in case of an emergency:
 - 1. The west side of North Holden Street from the south curb line of West Van Buren Street to a point 325 feet southerly thereof from 7:00 a.m. to 4:00 p.m. on days when school is in session.
 - 2. The east side of North Holden Street from the south curb line of West Van Buren Street to a point 277 feet southerly thereof from 7:00 a.m. to 4:00 p.m. on days when school is in session.
- N. Pursuant to sec. 346.505(2), Stats., no person shall park, stop or leave standing any vehicle, whether attended or unattended and whether temporarily or otherwise, within, upon, or so as to obstruct, block or otherwise limit the use of the designated space or portion of the following streets, highways or parking facilities, which shall be reserved, by official traffic signs indicating the restriction, for vehicles displaying special registration plates or special identification cards for physically disabled persons, as defined under sec. 346.503(1), Stats.:
 - 1. The easterly most parking space located on the south side of East Main Street, between North Wisconsin Street and North Franklin Street.

- 2. The westerly most parking space located on the north side of East Pier Street, between North Wisconsin Street and North Franklin Street.
- 3. The first parking space located on the south side of East Pier Street, east of Harborview Lane.
- 4. The first parking space located on the east side of S. Wisconsin Street north of Sauk Creek.
- 5. A parking space located on the east side of South Webster Street from a point 238 feet south of the south curb line of W. Grand Avenue to a point 274 feet from the south curb line of W. Grand Ave.
- 6. The first parking space located on the west side of South Webster Street, south of West Foster Street.
- 7. The first parking space located on the south side of West Foster Street, west of South Webster Street.
- 8. From a point on the north side of Whitefish Rd., 155 feet east of the east curbline of N. Holden St. to a point 20 feet easterly thereof.
- 9. On the west side of Lake Street, the northern most 30 feet of the angled parking.

O. Use Of School Bus Warning Lights.

1. <u>Duties of school bus operators.</u>

- (a) Warning lights required. Notwithstanding the provisions of sec. 346.48(2)(b)(2), Wis. Stats., adopted by reference in section8.01.010 and except as provided in subsection 1(b) of this section, the operator of a school bus shall use the school bus flashing red warning lights in a residence or business district in the city when pupils or other authorized passengers are to be loaded or unloaded at a location at which there are no traffic signals and such persons must cross the street or highway before being loaded or after being unloaded. Such flashing red warning lights shall be actuated by the operator at least 100 feet before stopping to load or unload pupils or other authorized passengers, and the operator shall not extinguish such lights until loading or unloading is complete and persons who must cross the street or highway are safely across. Where the curb and sidewalk are laid on one side of the road only, the operator shall use the flashing red warning lights when loading or unloading passengers from either side.
- (b) Warning lights prohibited. Pursuant to sec. 349.21(2), Wis. Stats., the operator of a school bus shall not use the school bus flashing red warning lights when pupils or other authorized passengers are loaded or unloaded directly from or onto the school grounds or that portion of the right-of-way between the roadway and the school grounds in a zone designated by "school" warning signs as provided in sec. 118.08(1), Wis. Stats. In which a street or highway borders the grounds of a school.

(c)

2. Other vehicles to stop.

The operator of a vehicle which approaches from the front or rear of any school bus which has stopped on a street or highway and is displaying flashing red warning lights shall stop the vehicle not less than 20 feet from the bus and shall remain stopped until the bus resumes motion or the school bus operator extinguishes the flashing red warning lights. The operator of any school bus which approaches from the front or rear of another school bus which has stopped and is displaying flashing red warning lights shall display its flashing red lights while stopped. This subsection shall not apply to operators of vehicles proceeding in the opposite direction on a divided street or highway.

5. Regulations for County owned Park and Ride Lot on Seven Hills Road.

- A. Sales and solicitation is prohibited at county park and ride lot.
- B. Parking in excess of 72 hours is prohibited at county park and ride lot
- C. The use of county park and ride lot for special events is prohibited unless permission is requested from and granted by Ozaukee County Public Works Committee.
- D. Except for emergencies or with the approval of the Ozaukee County Sheriff's Department, parking detached trailers is prohibited at county park and ride lot.

For purposes of this subsection, a "trailer" is defined as a vehicle without motive power designed for carrying property or passengers wholly on its own structure and for being drawn by a motor vehicle, but does not include a mobile home.

E. Parking trucks that weigh in excess of 8,000 pounds is prohibited at the county park and ride lot.

The Board of Public Works is hereby directed to procure, erect and maintain appropriate standard traffic signs, signals and markings giving notice and adequate warning of this ordinance to users of the streets and highways, as provided in sec. 8.09.010 of this Municipal Code.

8.05.080 Nonmoving Traffic Violations, Enforcement. All persons charged with a "nonmoving traffic violation", as used herein being any parking of a vehicle in violation of a statute or an ordinance, shall be subject to Section 345.28, Wisconsin Statutes, as may be amended, revised or modified. Such person may pay the applicable amount of forfeiture to the Port Washington Police Department within 28 days of issuance of the violation citation. In such event, the citation shall not be filed in court. If the alleged

violator fails to pay the applicable amount of forfeiture or fails to appear in court, the Port Washington Police Department, by its authorized representative, may proceed to issue a summons or may notify the Department of Transportation that a citation has been issued and remains unpaid. In the latter case, the Port Washington Police Department may request suspension of the registration of the vehicle involved or request that registration be refused of any vehicle owned by the person under Section 341.10 (7) (m), Wisconsin Statutes, or both.

8.06.000 WEIGHT LIMITS AND HEAVY TRAFFIC ROUTES.

8.06.010 Class B Highways Designated. All streets and alleys within the City of Port Washington, Wisconsin, except the following enumerated streets and alleys, are hereby designated Class "B" Highways and shall be subject to the weight and limitations imposed by S. 348.16, Wis. Stats.

1. All of State Trunk Highways 32 and 33 within the City limits, unless otherwise designated by the county board.

- B. In this section, "heavy traffic" means all vehicles not operating completely on pneumatic tires and all vehicles or combination of vehicles, other than motor buses, designed or used for transporting property of any nature and having a gross weight of more than 6,000 pounds.
- C. Other streets. No vehicle, except a motor bus, which is not operating completely on pneumatic tires or has a combined gross vehicle load weight exceeding 6,000 pounds, shall be operated or moved on any street or alley in the City not part of the heavy traffic route designated in Subsection A. of this section, except for the purpose of obtaining orders for supplies or moving or delivering supplies or commodities to or from a place of business or residence which has an entrance on such street, provided that in no event shall the weight of the vehicle or combination of vehicles and load on such street exceed the limitations of sec. 348.15(3), Stats. pertaining to "class A" highways or sec. 348.16(3), Stats. pertaining to pickup or delivery on "class B" highways.
- D. Notwithstanding Subsection C. of this section, no vehicle, except a motor bus, which is not operating completely on pneumatic tires or has a combined gross vehicle load weight exceeding 6,000 pounds, shall be operated or moved on Larabee Street between North Spring Street and North Maple Street, except for the purpose of

obtaining orders for supplies or moving or delivering supplies or commodities to or from a residence which has an entrance on such street, provided that in no event shall the weight of the vehicle or combination of vehicles and load on such street exceed the limitations of sec. 348.15(3), Stats. pertaining to "class A" highways or sec. 348.16(3), Stats. pertaining to pickup or delivery on "class B" highway

8.09.000 OFFICIAL TRAFFIC SIGNS AND SIGNALS.

8.09.010 Board of Public Works to Procure and Erect Signs and Signals.

The Board of Public Works is hereby authorized and directed to procure, erect and maintain appropriate standard traffic signs, signals and markings conforming to the rules of the state highway division giving such notice of this ordinance as required by state law. Signs shall be erected in such locations and manner as the Board of Public Works shall determine will best effect the purposes of this ordinance and give adequate warning to users of the street or highway.

8.09.020 Removal of Unofficial Signs and Signals. The Board of Public Works shall have the authority granted by Section 349.09, Wis. Stats., and is hereby directed to order the removal of a sign, signal, marking or device placed, maintained or displayed in violation of this ordinance of Section 346.41, Wis. Stats. Any charge imposed on a premise for removal of such an illegal sign, signal or device shall be reported to the Common Council at its next regular meeting for review and certification.

- **8.11.000 TURNING REGULATED**. The Common Council of the City of Port Washington hereby determine that traffic conditions warrant the following additional restrictions on turning to those set forth in Section 349.10(1), Wis. Stats.
- **8.11.010** <u>U-Turns Prohibited</u>. No person shall make a U-turn at the following locations:
- 1. At the intersection of Grand Avenue and Franklin Street.
- **8.11.020** Disorderly Conduct with a Motor Vehicle. Whoever does any of the following may be ordered to forfeit as hereinafter provided:
- 1. Upon any street or highway, public or private property, makes or causes to be made any unreasonable noise, which disturbs or tends to disturb the peace and quiet of any person in the vicinity thereof by squealing tires of his/her motor vehicle, or by causing loud and unnecessary acceleration of such motor vehicle.
- 2. Operates a motor vehicle in such a manner as to cause dirt, stones, rubber or other debris to be thrown by the wheels of such motor vehicle upon the person or property of another or to be thrown in a manner creating or tending to create an unreasonable risk or hazard to others upon the roadway or adjoining pedestrian walkway.
- 3. Operates or uses a motor vehicle upon any street or highway, public or private property, within the City limits where a compression brake is in any way engaged on such motor vehicle, or any unit a part thereof, causing noise which disturbs or tends to disturb the peace and quiet of any persons in the vicinity thereof, except when engaged or activated to avert imminent danger. For purposes of this section, a "compression brake" means a device primarily on trucks for the conversion of the engine from an internal combustion engine to an air compressor for the purpose of braking without the use of or in addition to wheel brakes. This section shall not include or apply to fire trucks or fire equipment.

8.12.000 <u>REGULATION AND LICENSING OF BICY</u>CLES.

- A. <u>Definition</u>. The term "bicycle", as used in this section, shall mean a device propelled by the feet acting upon pedals and having wheels, any 2 of which are not less than 14 inches in diameter.
- B. <u>Registration Required</u>. No City resident shall ride or use a bicycle having wheels of 20 or more inches in diameter upon any public highway, street, alley or pedestrian way unless it is registered as herein provided. The transferee of ownership of a registered bicycle shall register it within 2 working days following such transfer.
- C. <u>Registration Procedure</u>. A bicycle shall be registered by completion of a registration application at the Police Department or City Hall setting forth the owner's name and address, a complete description of the bicycle and any other required information, and by payment of the appropriate registration fee. Upon registration, the City shall issue a

sticker to be permanently affixed to the bicycle in such a manner as it may require, unless the bicycle is being transferred to a different owner and bears an intact sticker.

- D. <u>Bicycle Required to be in Safe Condition</u>. No bicycle shall be registered that is not in safe mechanical condition as determined by the Port Washington Police Department. It shall be the responsibility of persons 16 years of age or older, or a parent or guardian of a child under 16 years of age, to inspect and maintain said bicycle in safe mechanical condition.
- E. <u>Registration Fees</u>. The registration fee for each bicycle shall be \$3.00 for an indefinite registration period. Registration shall be transferable upon a transfer of ownership for a fee of \$1.00. The fee for replacement of a non-intact registration sticker not accompanied by a transfer of registration shall be \$1.00.
- F. <u>Rules for Operation of Bicycles</u>. Every person operating a bicycle in the City shall be subject to all applicable provisions of this chapter and to applicable State Statutes relating to equipping and operating bicycles.
- G. <u>Warning</u>. The first time a child is detained by a law enforcement officer for violation of any of the provisions of this section, his parent, guardian or person having such legal custody may be advised as to the provisions of this section and further advised that any violation of this section occurring thereafter by this child or any other child under his care or custody may result in a penalty being imposed as hereinafter provided.

H. Penalties.

- 1. <u>Persons Under 12 Years of Age</u>. Any person under 12 years of age who violates any of the provisions of this section shall be reprimanded at the discretion of the police officer in a manner prescribed as follows:
 - a. The officer may, when appropriate, issue a warning card to the parents of a juvenile who is detained for a violation of any of the provisions of this section, informing them of the violation.
 - b. The violation shall be considered a matter of record and the appropriate police department juvenile incident report completed for referral. At that time a determination will be made as to whether to refer the matter to a juvenile court for further action or to summon the offender, accompanied by a parent or guardian, to police headquarters to discuss the nature of the violation, or
 - c. The violation shall not be considered a matter of record and the bicycle may be impounded for a period of time not to exceed 30 days.
- 2. <u>Persons 12 Years of Age or Over</u>. Any person 12 years of age or over who violates any of the provisions of this section shall be reprimanded or cited at the discretion of the police officer in a manner prescribed as follows:

- a. The violation shall not be considered a matter of record and the operator may be warned or referred for appropriate follow up, including a parental conference, or
- b. For any violation of Ch. 346, Wis. Stats., applicable to bicycles, the violator may be issued a citation and be required to appear in court or post bond in the amount as prescribed by the uniform bond schedule.
- 3. <u>Persons 18 Years of Age or Over</u>. Any person 18 years of age or over who violates any of the provisions of this section shall be issued a citation and shall be required to appear in court or post bond in the amount prescribed by the uniform bond schedule.
- I. <u>Impounding</u>. Whenever a bicycle shall be impounded for violations of the provisions of this section, it shall be surrendered at the Police Department at the expiration of the impoundment period to the owner if an adult or the parents or the guardian of the offender. In the case of the seizure of a bicycle because it has been found in the possession of a person not the legal owner thereof and the bicycle is not reclaimed by the legal owner thereof, it shall be sold at public auction after the expiration of 120 days from the date of seizure. The proceeds of the sale shall be remitted to the City Treasurer.

8.12.010 Bicycle Helmets.

- 1. Any person less than 16 years of age operating or riding on a bicycle on a public roadway, public sidewalk, public bicycle path, or any other public right-of-way under the jurisdiction and control of the City shall wear a protective helmet designed for bicycle safety. Such helmets shall meet or exceed the impact standards for protective bicycle helmets set by the American National Standards Institute (ANSI) or the Snell Memorial Foundation.
 - A. A person under 16 years of age shall not operate a bicycle, unicycle, skate board or scooter, nor shall they wear in-line or roller skates, nor ride upon a bicycle, unicycle, skate board, scooter, in-line or roller skates as a passenger, at a public skate board recreation facility under the jurisdiction and control of the City unless that person is wearing a properly fitted and fastened protective helmet that meets or exceeds the impact standards for bicycle helmets set by the American National Standards Institute (ANSI) or the Snell Memorial Foundation, or standards subsequently established by those entities.
- 2. No parent or guardian of any child shall authorize or knowingly permit such child to violate any of the provisions of this ordinance.
- 3. This ordinance applies to a child seated in an auxiliary child's seat or trailer designed for attachment to a bicycle.
- 4. Except as provided herein, violation of this section is an infraction punishable by a fine of not more than twenty-five (25) dollars. The parent or legal guardian having

- control or custody of the minor whose conduct violates this section shall be jointly and severably liable with the minor for the amount of a fine imposed pursuant to this subdivision.
- 5. The court may waive any fine for such person found guilty of violating the provisions of this ordinance if the person supplies the court with proof that between the date of the violation and the appearance date for such violation, the person purchased or otherwise obtained a helmet which meets the requirements of this ordinance.
- **8.13.000 PENALTY**. The penalty for violation of any provision of this ordinance shall be a forfeiture as hereinafter provided together with the cost of prosecution imposed as provided in Section 345.20 to 345.53, Wis. Stats.
- **8.13.010** <u>Uniform Offenses</u>. Except as provided in 8.13.040 for nonmoving traffic offenses, forfeitures, for violation of any provision of Chapter 341 to 348 adopted by reference in Section 1 of this ordinance shall conform to forfeitures for violation of the comparable state offense, including any variations or increases for second offense.
- **8.13.020** Special Local Regulations. Where not specifically provided to the contrary in 8.13.010, above, the forfeiture for violation of 8.02.000 through 8.12.000 of this ordinance shall be not less than \$10.00 nor more than \$200.00 for the first offense and not less than \$10.00 nor more than \$500.00 for the second offense within 2 years.
- **8.13.030** <u>Miscellaneous</u>. The forfeiture for violation of any provision of 8.01.020 of this ordinance shall be not less than \$50.00 nor more than \$500.00.
- **8.13.040** Parking. A. The forfeiture for all parking violations shall be ten (\$10.00) dollars if paid by mail or otherwise to the City Clerk within 72 hours of such violations; shall be fifteen (\$15.00) dollars if paid after 72 hours and within 10 days; shall be twenty (\$20.00) dollars if paid after 10 days and within 28 days; shall be thirty-five (\$35.00) dollars if paid after 28 days.
- B. Notwithstanding any other provision of this chapter, the forfeiture for a violation related to parking spaces or portions of streets, highways or parking facilities reserved for vehicles used by physically disabled persons shall be not less than \$150.00 nor more than \$300.00.
- C. The forfeiture for all other parking violations shall be ten (\$10.00) dollars if paid by mail or otherwise to the City Clerk within 72 hours of such violations; shall be fifteen (\$15.00) dollars if paid after 72 hours and within 10 days; shall be twenty (\$20.00) dollars if paid after 10 days and within 28 days; shall be thirty-five (\$35.00) dollars if paid after 28 days.
- **8.14.000** ENFORCEMENT. This ordinance shall be enforced in accordance with the provisions of SS. 345.20 to 345.53, Ch. 299 and S. 66.12, of the Wis. Stats.
- **8.14.010** <u>Uniform Citation</u>. The uniform citation promulgated under S. 345.11, Wis. Stats., shall be used for all violations under this ordinance including ordinances for which a statutory counterpart exists.

- **8.14.020** Parking Citations. Citations for all nonmoving traffic violations under this ordinance shall conform to S. 345.28, Wis. Stats., and shall permit direct mail payment of the applicable minimum forfeiture to the Police Department within five (5) days of the issuance of the citation in lieu of court appearance. The issuing officer shall specify thereon the amount of the applicable forfeiture as provided in this ordinance.
- **8.14.030** Notice of Demerit Points and Receipts. Every officer accepting a forfeiture penalty or money deposit under this ordinance shall receipt therefore in triplicate as provided in S. 345.26 (3) (b), Wis. Stats. Every officer accepting a stipulation under the provisions of this ordinance shall comply with the provisions of SS. 343.27 (2) Wis. Stats. and shall require the alleged violator to sign a statement of notice in substantially the form contained on the uniform traffic citation and complaint promulgated under S. 345.11, Wis. Stats.
- **8.14.040** Forfeitures in Treasury Officer to Post Bond, Qualify. Any officer accepting deposits or forfeited penalties under this ordinance shall deliver them to the City Treasurer within 20 days after receipt. Any officer authorized to accept deposits under S. 345.26, Wis. Stats., or this ordinance shall qualify by taking the oath prescribed by S. 19.01, Wis. Stats., and filing an official bond in the sum of \$1,000.00 as described by S. 19.01.
- **8.15.000 REFERENCE TO STATUTES.** References to specific statutory sections wherever used in this ordinance shall mean the Wisconsin Statutes of 1971.
- **8.16.000 REPEAL OF CONFLICTING ORDINANCES.** All ordinances regulating traffic upon the streets, alleys, and highways of the City of Port Washington, Wisconsin, and all ordinances or parts of ordinances heretofore enacted by the Common Council of the City of Port Washington, Wisconsin, are hereby repealed.
- **8.17.000 SEVERABILITY.** The provisions of this ordinance shall be deemed severable and it is expressly declared that the Common Council would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid and if any provision of this ordinance or the application thereof to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected thereby.
- **8.18.000 EFFECTIVE DATE.** This ordinance shall take effect and be in force from and after October 1, 1972, upon passage and publication as provided by law.

8.19.000 **SNOWMOBILES**.

8.19.010 State Snowmobile Laws Adopted. Except as otherwise specifically provided in this ordinance, the statutory provisions describing and defining regulations with respect to snowmobiles in the following enumerated sections of the Wisconsin Statutes are hereby adopted by reference and made part of this ordinance as if fully set forth

herein. Acts required to be performed or prohibited by such statutes are required or prohibited by this ordinance.

- 350.01 (Definition)
- 350.02 (Crossing Highways)
- 350.03 (Operations of Snowmobiles on or in the Vicinity of a Highway)
- 350.04 (Snowmobile Races, Derbies and Routes)
- 350.05 (Persons under 12 Operating a Snowmobile)
- 350.06 (Firearms and Bows)
- 350.07 (Driving Bear, Deer or Other Game Prohibited)
- 350.08 (Owner Permitting Operation)
- 350.09 (Head Lamps, Tail Lamps and Brakes)
- 350.10 (Miscellaneous Provisions for Snowmobiles Operation)
- 350.12 (Registration of Snowmobiles)

8.19.020 Snowmobile Routes Designated.

- A. Except as provided in SS. 350.02 and 350.03, Wis. Stats., no person shall operate a snowmobile upon any public right-of-way, in any public park, golf course or on any other public property in the City except as hereinafter designated. The following are designated snowmobile areas:
 - 1. Parks, Golf Courses and Recreational Areas. Operation of snowmobiles on marked routes or trails is authorized in the following public parks, golf courses and recreational areas subject to approval of the City Park Board:
 - i. Upper Lake Park, west of the easternmost roadway;
 - ii. The Athletic Field, within the prescribed, signed area;
 - iii. The former WEPCO right-of-way, where so indicated;
 - iv. The North and South industrial areas
- B. The City Park Superintendent is directed and authorized to procure, erect and maintain appropriate snowmobile route, trail or limit markers.
- C. Snowmobiles operated on designated snowmobile routes over public highways shall observe the rules of the road for motor vehicles set forth in Ch. 346, Wis. Stats., and (Chapter 8 of this code) (Ordinance dated October 6, 1970), which is hereby adopted by reference and made part of this ordinance as if fully set forth herein. Any act required to be performed or prohibited by such laws is required or prohibited by this ordinance.

8.19.030 Additional Regulations.

A. Speed. No person shall operate a snowmobile upon any public right-of-way or highway within the City of Port Washington at a speed in excess of that permitted or posted for other motor vehicles or in any public park, or area, at a speed in excess of 20 miles per hour.

- B. Hours of Operation. No person shall operate a snowmobile upon (any public highway or other public property) (in any public park) (public or private golf course or recreational area) (lake) or (upon any private premises open to the public for snowmobiling) within the City of Port Washington between the hours of 11:00 p.m. and 7:00 a.m.
- C. Unattended Vehicles. No person shall leave or allow a snowmobile owned or operated by him to remain unattended on any public highway or public property while the motor is running or with the starting key left in the ignition.
- D. Operation on Sidewalks or Malls Prohibited. No person shall operate a snowmobile on any sidewalk, pedestrian way or mall within the City.
- E. Operation on Private Premises Restricted. No person shall operate a snowmobile on any private property not owned or controlled by him within the City without the express consent or permission of the owner.
- F. Snow Cover. No person shall operate a snowmobile within the City of Port Washington in any previously designated area in the absence of an average snow cover in that area of less than three (3) inches.
- G. Operation on Icebound Waters. No person shall operate or ride upon a snowmobile on Lake Michigan at any time or place.

8.19.040 Accidents and Accident Reports.

- A. If he can do so without serious danger to his own snowmobile or to persons on board, the operator of a snowmobile involved in a snowmobile accident with the City of Port Washington shall stop his snowmobile and shall render to other persons affected thereby such assistance as may be practicable and necessary to save them from or minimize any danger caused by the accident and shall give his name and address and identification of his snowmobile to any person injured and to the owner of any property damaged in the accident.
- B. If the snowmobile accident results in death or injury to any person or total property damage in excess of \$200.00, every operator of a snowmobile involved in such accident shall, as soon as possible, notify the City Police Department of the accident and shall, within 10 days after the accident, file a written report thereof with the department on forms prescribed by it.
- C. If the operator of a snowmobile is physically incapable of making the report required by this section and there was another occupant in the snowmobile at the time of the accident capable of making the report, he shall make such report.
- D. "Snowmobile accident" means a collision, accident or other casualty involving a snowmobile.

8.19.050 Snowmobile Renters Licensed.

A. No person shall engage in the business of renting or leasing of snowmobiles to the public or of renting or leasing use of a snowmobile track or other private property to the public for the operation of snowmobiles thereon in the City of Port Washington unless he has a license therefore as provided in this section.

- B. Application for snowmobile renters' licenses shall be filed with the clerk and shall include the name of the owner of the premises of which such business will be conducted, the proposed period and hours of operation, the name of the person, firm or corporation which will conduct such business, the state registration number of such commercial owner, if any, and the registration numbers of any snowmobiles to be leased by such business and such other information as the Common Council shall require to consider such application. The application shall be accompanied by a fee of \$15.00, which shall be refunded to the applicant in the event a license is denied.
- C. No license shall be issued unless approved by the Common Council after a public hearing on the application. Notice of such hearing shall be given by publication of a Class 1 notice under Ch. 985, Wis. Stats. The Council shall approve issuance of the license only if it determines that the public health, safety and welfare will not be adversely thereby and that the following terms and conditions are met:
 - 1. The applicant must file proof of liability insurance in force covering the premises to be licensed and any snowmobile to be rented or offered for use to the public by the applicant with limits of \$50,000/\$300,000/\$10,000.
 - 2. The use of the premises must conform with the requirements of the zoning regulations of the City and be approved by the building inspector.
 - 3. Snowmobiles shall be operated on the premises or leased for off-premises operation only between the hours of 7:00 a.m. and 11:00 p.m.
 - 4. The licensing period shall be for one year from July 1 to June 30. A reduction of up to 50% in the license fee may be granted by the Council for original licenses granted after June 30, but no reduction or refund of the fee shall be granted for any other reason.
 - 5. The Clerk shall issue a renewal license to any person, firm or corporation holding a valid license under this section upon payment of the annual license fee, provided, however, that any such applicant who has been convicted within the preceding 12 months of violation of this ordinance of any State Statute regulating or restricting the use of snowmobiles or snowmobile renters shall not be entitled to license renewal until renewal is approved by the Council after a public hearing as required under 8.19.050 C.

8.19.060 Penalty. Any person who shall violate any provision of this ordinance shall upon conviction thereof forfeit not less than \$10 nor more than \$20 together with the cost of prosecution for the first offense and not less than \$25 nor more than \$50 together with the cost of prosecution for the second offense within a year.
